The appropriation of cultural elements from colonized regions by British authors has sparked debates about authenticity and the ethical use of cultural material. In "Midnight's Children," Rushdie weaves a complex narrative that intertwines the personal and national histories with the political and cultural transformations of post-independence India. The novel addresses the consequences

of British colonial rule and the challenges of forging a new identity in the aftermath.
